Martin Minarik has extensive experience from executive and management positions both in private and public sector. He worked in marketing and advertising at Starcom MediaVest Slovakia delivering media campaigns for wide-known brands such as Samsung, HSBC, RWE, Honda and others. In the position of Advisor at the Foreign Relations and Protocol Department at the Slovak Parliament he participated in high-level event management, and drafted Speaker's official correspondence and background materials on EU affairs. As a Director of Chairman's Office at the

Slovak Quality Infrastructure Authority he coordinated international cooperation with partner authorities abroad. He also held a position of Deputy Director for Marketing and PR at Slovak Folk Crafts Agency where he was responsible primarily for agency's communication and media relations. Most recently he worked at EU Issue Tracker, a Brussels-based legislative monitoring service, and at the Energy Charter Secretariat, focusing on energy and climate change related issues, where he also published a paper on Energy Cooperation in Central Europe.

Martin holds a Masters degree in International Relations and Diplomacy from the University of Economics in Bratislava (Slovakia) and the College of Europe in Bruges (Belgium). His thesis on approximation to EU technical standards "with and without the promise of EU membership", based on the cases of Slovakia and Ukraine was published as <u>EU Diplomacy Paper</u> no. 2/2013 in January 2013.

The presentation discussed the protection of critical energy infrastructure from the point of view of an international energy organisation, the Energy Charter, which is the only multilateral legally binding agreement providing rules for global energy governance and security, mainly in the areas of energy trade, transit, investment promotion and protection, energy efficiency as well as dispute settlement.

The presentation is structured as follows. It first shortly introduces the Energy Charter as an organisation and its main objectives. It then outlines the main activities of the Energy Charter in the area of energy security, namely the Energy Security Contact Group and the Early Warning Mechanism. It concludes with an outline of joint activities in this area together with the OSCE.
